

COMPILATION AND VALIDATION OF THE WORKING STUDENT JUSTIFICATION FORM

- **Art. 1** This form is valid (upon obtaining the requirements of Art. 3) for the purpose of certifying the presence of students at lectures and/or exams and is requested **by working students for submission to their employer** according to Art. 10, Law n. 300/1970.
- **Art. 2** The form must be completed **digitally** using interactive and detailed fields to ensure data completeness.
 - **a.** It is recommended to download the file from the <u>web repository</u> and fill it out locally using the free PDF reader "**Acrobat Reader**" which allows for the correct display of each field's details.
 - **b.** It is **mandatory** to follow the completion process to maintain the integrity of the data entered by the student, which is **necessary** for subsequent validation processes.

After downloading the document:

- I. Digitally **complete** all fields in the form.
- II. **Print** the document.
- III. **Scan** the document and save it as a .pdf file (preferably in **PDF/A** format).
- **Art. 3** The **validation** of the justification can be done in **two** ways:
 - a. AUTOGRAPH signature.

At the student's request for the justification - during the exam or lecture - the teacher signs and sends the request for **departmental stamp** via email to the address didattica.mift@unime.it.

b. DIGITAL Signature. (No need for departmental stamp):

At the student's request for the justification - during the exam or lecture - the teacher receives the PDF file (according to Art. 2, Comm. B, P. III), signs it digitally (with **InfoCert** graphic signature via the **U-SING** portal), and forwards it to the student.
